

## The Best Way to Expose Logical Fallacies

In [my last post](#) I talked about something I've been noticing recently, that people, especially pro-life nerds like me, are tempted to talk about logical fallacies all the time in conversation.

There are several dangers to this. I've argued already that the first danger is accusing somebody of a logical fallacy when they didn't actually commit one. If you dedicate yourself to educating yourself on what the logical fallacies actually are before bringing them up, you will be a more effective debater. But there's a good, better, best aspect to exposing logical fallacies *while creating good dialogues with people.*



***I think the best way to expose logical fallacies is to note the specific fallacy mentally and then use questions to show the person the problem, without name dropping the specific fallacy.***
